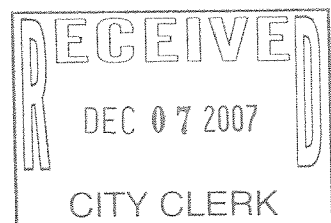

Dear Ms. Kruse:

After reviewing the report of contributions and expenditures submitted on December 3, 2007, for the above referenced candidate committee, I should advise you of Article XXVIII, Section 3 paragraph 6 of the Colorado Constitution which states: "No candidate's candidate committee shall accept contributions from, or make contributions to, another candidate committee, including any candidate committee, or equivalent entity, established under federal law." I note from your latest report that you list contributions from the Committee to Elect Peggy Cole and the Debbie Brinkman 4 Littleton Committee, an apparent violation of the above referenced section.

I also reviewed the reports you submitted on October 16, 2007 and October 29, 2007 indicating that contributions were received from Homewood Furniture (October 16, 2007 report) and the Littleton Cemetery Association (October 29, 2007 report). I want to advise you that Article XXVIII, Section 3, paragraph 4(a) of the Colorado Constitution states: "It shall be unlawful for a corporation or labor organization to make contributions to a candidate committee or a political party, and to make expenditures expressly advocating the election or defeat of a candidate; except that a corporation or labor organization may establish a political committee or small donor committee which may accept contributions or dues from employees, officeholders, shareholders, or members." After reviewing the records of the Secretary of State, it would appear that both Homewood Furniture and the Littleton Cemetery Association are Colorado Corporations and would therefore be subject to Article XXVIII, Section 3, paragraph 4(a), of the Colorado Constitution.

The sanction for these types of violations can be found in Section 10, paragraph 1: "Any person who violates any provision of this Article relating to contribution or voluntary spending limits shall be subject to a civil penalty of at least double and up to five times the amount contributed, received, or spent in violation of the applicable provisions of this Article. Candidates shall be personally liable for penalties imposed upon the candidate's committee."

According to Rule 6.1 of the Colorado Secretary of State's Rules Concerning Campaign and Political Finance (as amended 9/19/07) (the "Rules"): "If the appropriate officer, as defined in Section 2(1) of Article XXVIII, discovers a possible violation of Article XXVIII or Title 1, Article 45, and no complaint alleging such violation has been filed with the secretary of state pursuant to Article XXVIII, Section 9(2)(a), then the appropriate officer shall:

- a. Provide the person believed to have committed the violation with written notice of the facts or conduct that constitute the possible violation, and
- b. Allow seven business days to correct the violation or to submit written statements explaining the reason that support a conclusion that a violation was not committed."

According to Kristine Reynolds of the Colorado Secretary of State's office, Rule 4.8 of the Rules has been interpreted to allow contributions from a prohibited source to be returned to the contributor within 30 days.

Please contact me as soon as possible to explain how the apparent violation will be corrected or with a written explanation supporting a conclusion that a violation was not committed.
